

ORDINANCE NUMBER 1617

AN ORDINANCE AMENDING CHAPTER 10  
OF THE HARRISBURG MUNICIPAL CODE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF HARRISBURG AS FOLLOWS:

SECTION ONE: There is hereby added to the Harrisburg Municipal Code, Chapter 10-26, 10-27, and 10-28, which shall read as follows:

Division 1. GENERALLY

VIDEO GAMING TERMINALS

**Sec. 10-26. License Required.** It is unlawful for any person, firm or corporation to operate a video gaming terminal, as defined in the Illinois Video Gaming Act (230 ILCS 40/5), without a City Video Gaming License. No City Video Gaming License shall be issued unless the person, firm or corporation has complied with the Illinois Video Gaming Act and holds a valid Illinois Video Gaming License.

**Sec. 10-27. Annual Terminal Fee.** An annual fee of \$25.00 shall be imposed on each video gaming terminal.

**Sec. 10-28. Penalty.** Any violation of the provisions of this Ordinance shall subject the violator to a fine of up to \$750.00. Each day a violation is committed by a violator shall be a separate offense. A second violation of this Ordinance shall result in suspension of the City Video Gaming License, in addition to the fine. Any subsequent violation of this Ordinance shall result in revocation of the City Video Gaming License, in addition to the fine.

**SECTION TWO:** Partial invalidity. If any section, subdivision or sentence of this Ordinance is for any reason held invalid or unconstitutional, such decision shall not affect the validity of the remaining portion of this Ordinance.

**SECTION THREE:** That this Ordinance shall be in full force and effect from and after its passage, approval, and publication as provided by law. w.
